- December: Ray & Associates will post the job opening, and the Board will invite the community to provide feedback about what they want in our next superintendent.
- January: Ray & Associates will conduct focus groups to receive feedback about what is wanted in our next superintendent. Those interested in serving on a focus group will fill out an online application form by January 3.
- February: The Board will interview candidates and select finalists.
- March: The Board will select superintendent.
